



## Vegetable Stock Base

### PREPARATION

Add base to cold water, bring to a rolling boil and serve. Mix ratio is 454 g (1 lb) base to 24 l water. 4.54 kg (10 lb) Base produces ~ 240 l of soup

### USAGE

The product is designed to be added to soups, stews, gravies, or sauces. It can also be used as a delicious hot drink or consommé.

### INGREDIENTS

Sugar (Dextrose), Salt, Hydrolyzed Corn Protein (Corn, Sunflower Oil), Onion Powder, Dehydrated Vegetables (carrots, potato, onion, leeks, red and green bell peppers, cabbage, celery), Silicon Dioxide, Spices (pepper, parsley), Caramel Colour.

### STORAGE CONDITIONS

Store in a cool, dry location not to exceed 30°C. Reseal container when not in use.
