



## Beef Soup Base – Lower Sodium

### DESCRIPTION

A sodium reduced version of the Donmar beef soup base.  
Certified Kosher Parve and Vegan.

### PREPARATION

Add base to cold water, bring to a rolling boil and serve.  
Mix ratio is 454 g (1 lb) base to 12 l water.  
4.54 kg (10 lb) Base produces ~ 120 l of soup  
11.34 kg (25 lb) Base produces ~ 300 l of soup

### USAGE

The product is designed to be added to soups, stews,  
gravies, or sauces. It can also be used as a delicious hot  
drink or consommé.

### INGREDIENTS

Sugar (Maltodextrin, Dextrose), Hydrolyzed Corn Protein  
(Corn, Sunflower Oil), Corn Flour, Vegetable Oil (Canola),  
Onion Powder, Corn Starch, Caramel Colour, Silicon  
Dioxide, Spices (Paprika, Pepper, Celery), Natural Flavour.

### STORAGE CONDITIONS

Store in a cool, dry location not to exceed 30°C. Reseal  
container when not in use.
